I, Keith Edward Livingway/Livernois, the undersigned inscriber, affirm that I will be faithful and bear true allegiance to The United States of America, a Nation unto itself, and a Confederacy form of Government, and as a free and Independent Nation as long as the law of free will and choice is respected and upheld as established by the one true source; and that I will not at any time do or cause to be done, any matter or thing, that will be prejudicial or injurious to the freedom and Independence thereof; and, also, that I will discover and make known to someone National, while holding the office of Post Master General for The United States of America, all treasonous or traitorous conspiracies which I now have or hereafter shall know to be formed against this or any of The United States of America. I will also abide by the constitution for The United States of America, as amended, The Articles of Confederation, agreed to by the United States, in Congress assembled, November 15th, 1777, ratified and in force March 1st, 1781, brought forward to the present time, as amended last on the 5th day of September, 2012, The General Post Articles as amended, and all other documents ratified and amended, now therefore,

Declaration of Chain of Title

IT IS DECLARED THAT; the office of the Postmaster General of the Confederacy of The United States of America of 1775, first held by Doctor Benjamin Franklin on 26th of July 1775, was succeeded by *Richard Bache* on November 7th, 1776, succeeded by Ebenezer Hazard on the 28th day of January, 1782, and died in the year of 1817 without naming a successor. The office of the Postmaster General of the Confederacy of The United States of America of 1775 was vacant from the year 1817 until the year 2010.

The office of the Postmaster General of the Confederacy of The United States of America is succeeded by Keith Edward Livingway, on April 2nd, 2012, and re-affirmed on 8th day of February 2014; although claimed on or about March of 2010 by claiming the original General Post Office of the Confederacy of The United States of America by public notice.

The claim to the General Post Office of the Confederacy of The United States of America was a result of claiming the metes and bounds and seaward boundaries of The United States of America of 1781 brought forward to the year 2009.
